[REDACTED] However, plaintiffs are informed and believe that First Look failed to exercise this discretion in good faith and in accordance with fair dealing, but instead botched the distribution of *The Ungodly* in myriad ways, including:

- Repeatedly claiming to lose the paperwork for the film (such as documentation of insurance) and insisting upon resubmission of the paperwork, resulting in delay;
- Repeatedly demanding revisions to deliverables which already had been accepted, resulting in delay and additional expense;
- Insisting upon a confusing name change from *The Ungodly* to *The Perfect Witness*;
- Failing to fully effectuate the name change, resulting in confusion in the marketplace;
- Failing to send the DVD to Ungodly – or even the Director – prior to distribution – which prevented the plaintiff from identifying and insisting

upon correction of a significant issue with the sound on the DVD that was released to the public;

- Releasing the DVD of *The Ungodly* with the sound improperly synched for the last – climactic – portion of the film;
- Falsely telling Ungodly that it had created “original” poster art which was in fact stock photograph;
- When another company used the same supposedly original poster art to promote a different film, stating that it would demand that the other company cease using the poster art but then failing to do so; and
- Stating that it would recall and replace the DVDs with improperly synched sound that had been distributed to outlets such as Blockbuster and Netflix, but then failing to do so.


